- It is the student's responsibility to notify the TAMUV Office of Financial Aid immediately if enrollment changes occur at either the Home School or Host School.
- Financial aid eligibility may be adjusted if enrollment differs from what was originally approved on the consortium agreement.
- Students are responsible for ensuring that an official transcript from the Host School is submitted to TAMUV upon completion of the coursework.
- Failure to successfully complete approved consortium coursework may impact future financial aid eligibility, including Satisfactory Academic Progress (SAP).
